Applications are invited from the eligible Candidates for admission into the **Five Year Integrated BB.A. LL.B.(Honours), B.Com. LL.B. (Honours) and B.A. LL.B. (Honours) Programme** for the Academic Session 2021-2022.

Eligibility for Admission: A candidate for admission to the Five- year **BB.A. LL.B.(Honours), B.Com. LL.B. (Honours) and B.A. LL.B. (Honours)** Courses shall have passed the Higher Secondary Examination (10+2) or an equivalent examination securing at least 45% in aggregate of the total marks for GENERAL CATEGORY applicants and 40% for SC, ST and OBC applicants.

(Any other issue of eligibility shall be decided as per BCI rules)

Owing to the COVID-19 Pandemic and the instructions of Dibrugarh University (our affiliating University) and the Government to prevent the spread of the Corona Virus, the College is taking special measure to encourage admissions through online mode.

Therefore, the following step by step procedure is to be followed by the applicants to apply for admissions for the Session 2021-2022.

STEPS TO BE FOLLOWED:

Step- 1. Download the admission form from the website www.sipe.in.

Step-2. Fill up the form distinctly / legibly with **Black Ball-Point Pen in Block Letters** and e-mail the scanned copy of the same to the address sipelawcollege@gmail.com with the following scanned documents:-

(Please use Adobe Scan / Clear Scan / Microsoft Lens or any other good scanner app / scanner machine. General photographed images will not be accepted)

- a) HSLC (or equivalent examination) pass certificate / admit card.
- b) Cast Certificate (if applicable)
- c) Higher Secondary (10+2) marksheet, pass certificate and admit card.

NOTE: Students who have appeared in the 10+2 examination and are awaiting results can also apply. In that case applicants are to submit a) H.S Final Admit Card b) H.S 1st Year marksheet

Step-3. On receipt of the application from the student, the College will issue an acknowledgement and APPLICATION REFERENCE No. through e-mail.

Step-4. The College will inform the selected applicants via e-mail/Phone call / Whatsapp about his status within 3 days from the receipt of application. (Students are advised to mention a mobile No. having Whatsapp in the application form).

Step-5. The selected applicants/candidates are to deposit the admission fees of Rs. 17,300/- (which includes the first semester tuition fee amounting to Rs.17,100/- per Semester + college registration fees amounting to Rs. 200/-) to the following bank account details within 7 (seven) days from the receipt of confirmation of admission through internet banking/debit card/RTGS/NEFT etc. There will be no admission fees or any other fees payable to the College per Semester in excess of the amount specified above. However, the Student will have to pay one time nominal sum fixed by Dibrugarh University for their Registration and nominal Semester Examination fees in each Semester to the Dibrugarh University separately.
